

## CONDITIONS OF ISSUE

Hancock Forest Management Ltd allows access through and recreational activities within the forests they manage. For your own safety and the safety of workers in the forest it is important that you comply with the conditions of this permit.

Remember by obtaining a permit you can be directed away from hazardous areas where logging operations are taking place. These operations are often dangerous and involve use of heavy machinery . we don't want you getting in the way of these operations and putting yourself at risk.

Visitors are warned that the following hazards exist in the forest in the course of forest operations

- Moving vehicles including oversized logging trucks.
- Falling & airborne matter including aerial spraying.
- Stacked logs & skid (log processing) sites.
- Dangerous machinery.
- Excessive noise levels.

Access may be limited in periods of high fire danger. A fire in the forest could put people in danger as well as it could cost workers jobs and lose valuable income for this region, the country and the forest owners.

Many people in the region rely on forests for their livelihoods . please act responsibly at all times and don't put them at risk.

1. The lighting of fires at any time is totally prohibited and absolute caution must be taken at all times not to cause a fire.
2. Permission to cross any private land must have prior consent of the owner or occupier.
3. The cutting, felling or removal of any live trees, shrubs or other forest produce is strictly prohibited unless specifically approved as a special condition on the front of this permit.
4. This permit is not transferable to other persons or vehicles. It applies only to the person(s) and the vehicle(s) named on the permit. It must be carried at all times and be produced on demand.
5. The permit may be cancelled by public notice issued by radio or published in a newspaper of the district where the forest exists.
6. While this permit confers permission to enter land as specified on this permit, the holder of the permit agrees that they do so entirely at their own risk.
7. Hancock Forest Management (NZ) Ltd does not accept liability for any loss or damage suffered by any person within the forests managed by Hancock Forest Management (NZ) Ltd pursuant to this permit, whether that damage arises as a consequence of negligence of Hancock Forest Management (NZ) Ltd or any of its officers or employees, or otherwise.
8. Permit holders are warned that poisoning for opossums and other animals may occur in the area covered by this permit and are therefore cautioned against touching or approaching any baits, lures, or carcasses found.
9. Please note that dogs are very susceptible to 1080 poison and you will need to take particular care of dogs under your control in the forest.
10. Hunting or shooting during the hours of darkness is prohibited unless specifically approved as a special condition on the front of this permit.
11. Hunting from aircraft (helicopter/fixed wing) on any Hancock Forest Management (NZ) Ltd forestland is strictly prohibited.
12. Camping is prohibited unless specifically stated on the front of this permit as a special condition.
13. This permit does not confer any permittee trout fishing or game bird shooting rights on any Hancock Forest Management (NZ) Ltd forestland. A separate fishing license or game bird license must be obtained from the appropriate authority.
14. Under NO circumstances is any household rubbish, garden waste, prunings, whiteware or car bodies to be disposed of in or adjacent to any Hancock Forest Management (NZ) Ltd managed Forests.
